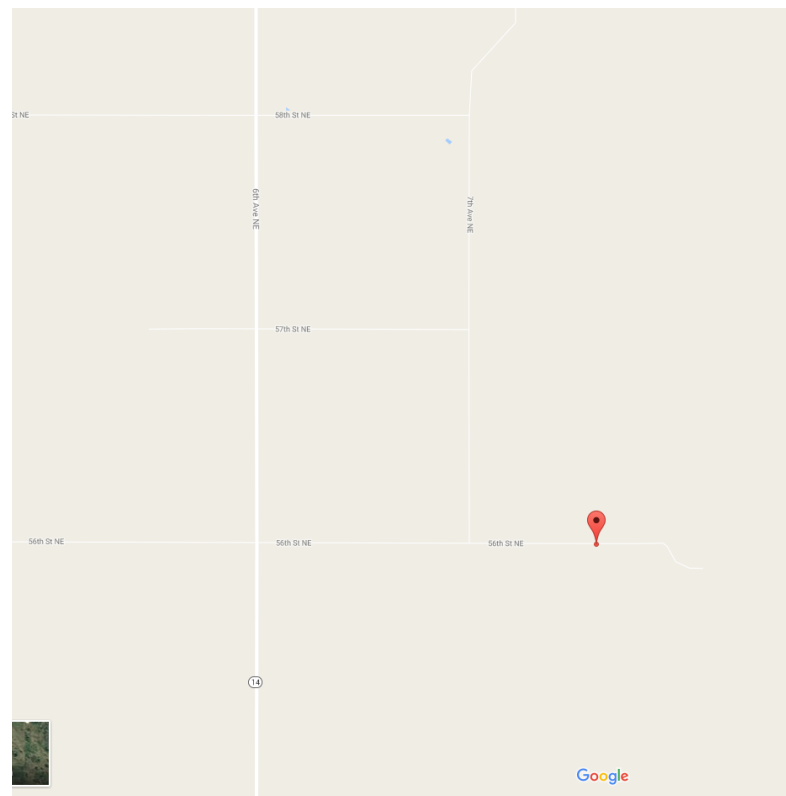

### DIRECTIONS

**From I-94,** take the Hwy 281 North Truck route that is west of Jamestown, ND.. This will allow you to avoid the city traffic. Go north on Highway 14 for 21 miles, turn right onto 56th St and go 1.5 miles to drive on left.
