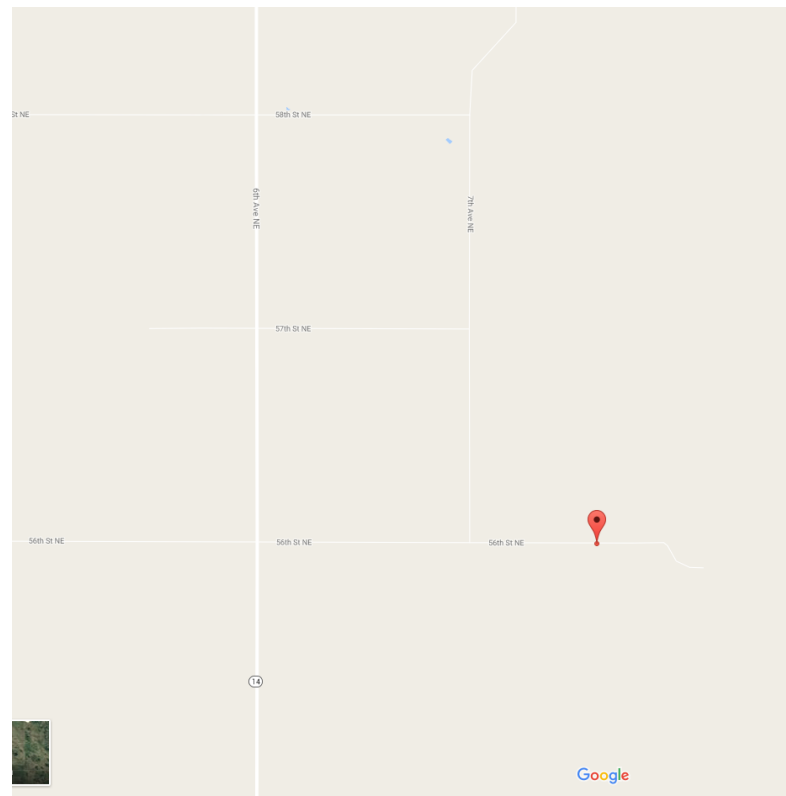

DIRECTIONS

From I-94, take the Hwy 281 North Truck route that is west of Jamestown, ND.. This will allow you to avoid the city traffic.
